#### **Information We Collect**

We collect the following types of personal information from you:

- Personal Identification Information: such as your name, address, email address, phone number, and any other information you provide.

- Transaction Information: such as payment information, transaction history, and service usage details.
- Sensitive Information: such as your Social Security Number, financial information for processing payment, and any necessary medical information.

### **How We Use Your Information**

We use the personal information we collect for the following purposes:

- To provide and manage our services.
- To communicate with you regarding your account, transactions, or employment.
- To comply with legal obligations, such as tax reporting and regulatory requirements.
- To improve our services and ensure a secure and efficient experience for all users.



#### **How Your Information is Shared**

We do not share your personal information with third parties, except in the following situations:

- With Service Providers: We may share your information with trusted service providers who perform services on our behalf, payment processing, customer support, and data storage. These service providers are required to protect your information and use it only for the purposes we specify.
- **Legal Obligations**: We may disclose your information if required to do so by law, or in response to a subpoena, court order, or other legal process.
- Business Transfers: In the event of a merger, acquisition, or sale of our assets, your information may be transferred to the new entity, subject to the same privacy protections.

## SMS Opt-In, Verifiable Consent, and Phone Number Privacy

If you provide your phone number for SMS notifications or communications, we want to assure you that:



Your SMS Opt-In and Phone Numbers Are Not Shared: We will not share your TOWNSEND TREE SERVICE phone number or SMS opt-in information with any third parties or affiliates. Your phone number will only be used for communication directly related to the services we provide or to your relationship with Townsend.



Verifiable Consent: By providing your phone number and agreeing to receive SMS RUW-LARE communications, you provide verifiable consent to receive such messages. We document and store this consent as required by law. If you do not provide this consent, we will not send you SMS messages.



Opt-Out for Non-Company-Owned Devices: If you are using a non-company-owned ? device, you have the right to opt-out of receiving SMS messages at any time. You can TOWNSEND opt-out by replying "STOP" to any message you receive from us. Once you opt-out, ARBORCARE we will no longer send SMS messages to your personal device.



## **Your Rights and Choices**

You have the right to:

- Access and update your personal information.
- Request the deletion of your personal information, subject to certain legal requirements.
